Comment on volumes: Very little known about this stream and rate of arising. Actual quantity will be established when solvent tanks are emptied. Studies of the tank have shown that the maximum volume of crud in stock is 10 m<sup>3</sup>. The lower uncertainty factor is notional. Note it will not be possible to determine the volume precisely until the tank is drained.

Uncertainty factors on volumes: Stock (upper): x 1.0 Arisings (upper) x 1.5  
 Stock (lower): x 0.01 Arisings (lower) x 0.5
