General description: The waste is mostly metallic waste associated with redundant plant items and building fabric. Quantities of compactable secondary waste will also be generated. The waste has not undergone any changes since it was generated.

**RADIOACTIVITY**

Source:

The activity has arisen from historical reprocessing operations within the facility. Waste has become contaminated as a result of these operations plus subsequent decommissioning.

Uncertainty:

The uncertainty associated with the fingerprinting analysis is likely to be low, however the volumes and total activity information (and possibly some other assumptions) are likely to be more notional and thus more uncertain.

Definition of total alpha and total beta/gamma:

Where totals are shown on the table of radionuclide activities they are the sums of the listed alpha or beta/gamma emitting radionuclides plus 'other alpha' or 'other beta/gamma'.

Measurement of radioactivities:

Specific activity data is based on data in the corresponding WCH, which in turn maps an estimated total activity to an analytically derived radionuclide fingerprint.

Other information:

The radionuclides have been taken from 2019 UKRWI LLW Forecast and are based on the current WCH.
