Source:

The activity arises as a result of processing raffinates from reprocessing operations. The waste has become contaminated during routine operations.

Uncertainty:

The uncertainty associated with the fingerprinting analysis is likely to be low, however the volumes and total activity information (and possibly some other assumptions) are likely to be more notional and thus more uncertain.

Definition of total alpha
and total beta/gamma:

Where totals are shown on the table of radionuclide activities they are the sums of the listed alpha or beta/gamma emitting radionuclides plus 'other alpha' or 'other beta/gamma'.

Measurement of
radioactivities:

Specific activity data is based on data in the corresponding WCH, which in turn maps an estimated total activity to an analytically derived radionuclide fingerprint.
