RADIOACTIVITY

Source:

The activity has arisen from the operation of the Calder Hall power station. The wastes are decommissioning wastes plus contaminated secondary wastes.

Uncertainty:

The uncertainty associated with the derived fingerprint is likely to be relatively low, however the volumes and total activity information (and possibly some other assumptions) are likely to be more notional and thus more uncertain.

Definition of total alpha and total beta/gamma:

Where totals are shown on the table of radionuclide activities they are the sums of the listed alpha or beta/gamma emitting radionuclides plus 'other alpha' or 'other beta/gamma'.

Measurement of radioactivities:

Specific activity data is based on data in the corresponding WCH, which in turn maps an estimated total activity to an analytically derived radionuclide fingerprint.

Other information:

The radionuclides have been taken from DEC-0828A and are based on the current WCH (1S-1S-0-WCH-0-3900).
