WASTE SOURCE Waste arises as a result of care and maintenance at the facility plus the clearance of historical wastes.

PHYSICAL CHARACTERISTICS

General description: The waste is mostly compactable secondary waste from both current care and maintenance and historical work. Quantities of hard waste associated with plant items and the building fabric will also arise. The waste has not undergone any changes since it was generated.

RADIOACTIVITY

Source:

The activity has arisen as a result of PIE of experimental fuel. The waste has become contaminated during care and maintenance.

Uncertainty:

The uncertainty associated with the fingerprinting analysis is likely to be low, however the volumes and total activity information (and possibly some other assumptions) are likely to be more notional and thus more uncertain.

Definition of total alpha and total beta/gamma:

Where totals are shown on the table of radionuclide activities they are the sums of the listed alpha or beta/gamma emitting radionuclides plus 'other alpha' or 'other beta/gamma'.

Measurement of radioactivities:

Specific activity data is based on data in the corresponding WCH, which in turn maps an estimated total activity to an analytically derived radionuclide fingerprint.
