RADIOACTIVITY

Source: Irradiated components removed from the reactor. Activated material removed from the reactor core is likely to be of high specific activity.

Uncertainty: Specific activity is a function of station operating history. The values quoted are indicative of the activities that might be expected.

Definition of total alpha and total beta/gamma: Where totals are shown on the table of radionuclide activities they are the sums of the listed alpha or beta/gamma emitting radionuclides plus 'other alpha' or 'other beta/gamma'.

Measurement of radioactivities: Estimates are based on theoretical assessments.

Other information: Estimates are based upon theoretical assessments. Other beta/gamma nuclides of arisings and stocks (in TBq/m³) include Cr51 (4E+02, 3E-01); Co58 (1E+02, 1E+0);Nb95 (3E-01, 7E-04) and Ru103 (2E-04, 6E-07). Other beta/gamma nuclides will also include Fe59.
