Comment on volumes: Arisings will originate from all unconditioned LLW streams. Arisings based the ratio of HHISOs already grouted containing only pucks: approximate arisings volumes = 16407m³. There will be high uncertainty in this number as how a HHISO is packaged will be based on the available waste types on the day. Stocks value is expected to rise as more waste is conditioned. The waste has already been generated and each item has a declared waste volume. This wastestream comprises of 53 conditioned HHISO containers containing supercompactable wastes only.

PHYSICAL CHARACTERISTICS

General description: Supercompactable wastes only. This consists of general and soft trash, including intractable organics, glassware and metal waste. Size reduced pipework and other plant items will also be present. This waste has been packaged into disposal containers and encapsulated with grout.
