General description: The waste is largely secondary wastes and also hard waste associated with the building fabric. The waste has not undergone any changes since it was generated.

**RADIOACTIVITY**

Source: The activity has arisen from the activation of concrete and metals during the operation of the pile plus contamination arising from the Pile 1 fire. The waste has become contaminated during care and maintenance of the facility plus preparatory work for decommissioning.

Uncertainty: The uncertainty associated with the fingerprinting analysis is likely to be low, however the volumes and total activity information (and possibly some other assumptions) are likely to be more notional and thus more uncertain.

Definition of total alpha and total beta/gamma: Where totals are shown on the table of radionuclide activities they are the sums of the listed alpha or beta/gamma emitting radionuclides plus 'other alpha' or 'other beta/gamma'.

Measurement of radioactivities: Specific activity data is based on data in the corresponding WCH, which in turn maps an estimated total activity to an analytically derived radionuclide fingerprint.

Other information: The radionuclides have been taken from REM\_TP\_0116A and are based on the current WCH.
