General description: The waste will be mostly compactable secondary waste plus empty plastic containers. There will also be metallic wastes associated with redundant plant items. The waste has not undergone any change since it was generated.

RADIOACTIVITY

Source: The activity arises from operations and maintenance activities within the plutonium purification and finishing areas of Thorp plus the product and residues store.

Uncertainty: The uncertainty associated with the derived fingerprint is likely to be relatively low, however the volumes and total activity information (and possibly some other assumptions) are likely to be more notional and thus more uncertain.

Definition of total alpha and total beta/gamma: Where totals are shown on the table of radionuclide activities they are the sums of the listed alpha or beta/gamma emitting radionuclides plus 'other alpha' or 'other beta/gamma'.

Measurement of radioactivities: Specific activity data is based on data in the corresponding WCH, which in turn maps an estimated total activity to a derived radionuclide fingerprint.

Other information: The radionuclides have been taken from REM_TP_0116A and are based on the current WCH (LLWR Ref: 1S-1S-0-WCH-0-4547 Version 14).
