Waste that is currently ILW: This waste is ILW at the time of arising. The waste is stored temporarily to allow decay of short lived radionuclides. Following this, the desiccant is transferred off-site for decontamination then either incineration or grouting to drums and transfer to LLW. Waste will be consigned as ILW prior to decontamination and therefore the decay period to LLW is not known.
