RADIOACTIVITY

Source: Contaminated effluent which passes through the column will be filtered by the GAC. Contamination by fission products, actinides and activation products.

Uncertainty: The fingerprints are conservative upper limits based upon the mass and activity of FED processed through GAC columns.

Measurement of radioactivities: Cs-137 and Co-60 both measured using in-situ gamma spectroscopy. Other radionuclides are taken from the specific activity of one package, as the inventory was calculated assuming all activity of FED was present in one package. Decayed to 01/04/2025.

Chemical form of radionuclides: H-3: Most tritium is expected to be present as water but some may be present in the inorganic compounds or as organic compounds.

C-14: Carbon 14 may be present as graphite
